

Photography Competition – May 2019



T&Cs

The title for this BV Dairy Photographic Competition is '**Animals, Birds, Fish or Reptiles**'. The theme is open to personal interpretation but we are looking for beautiful photographs that show the subject at its best or most spectacular.

Please take your photos responsibly and, if applicable, always follow the Countryside Code.

The Judges will choose their favourite entry. One entry is allowed per person. The closing date/time for entries is **midnight on Friday 26th July, 2019.**

Who can enter?

Entrants must be aged 16 or under at the closing date – Friday 26th July, 2019. All Entrants must have a parent's or legal guardian's consent to submit their image.

Entrants must not be professional photographers. For the purpose of this competition, a professional photographer will be considered to be anyone who makes more than half their annual income from the sales of their photographs.

Please ensure that your name, date of birth and contact details are submitted with the image.

How to enter?

Each participant may submit one entry. Captions can be included.

Photographs can be in digital format and submitted to Millie@bvdairy.co.uk. All digital images should be at least 1,000 pixels wide (if a horizontal image) or 1,000 pixels tall (if a vertical image) and must be in JPEG format.

Entries will not be returned so please remember to keep a copy. Unsuccessful entrants will not be contacted and no feedback on any entry will be provided.

Competition dates

Millie's Photography Competition will close at 2359 hours on Friday 26th July, 2019.

Competition judging

Once all entries are received they will be split into 3 age groups:

Up to and including 8 years
9 – 11 years (inclusive)
12 years and above.

Photographs will be judged on their originality, creativity, composition, photographic quality and relevance to the theme. Entries will be judged and Winners notified on or before Monday 5th August, 2019. The judges' decisions are final.

Competition prizes

A prize of a Family Ticket (2 adults and 3 children) to the Gillingham and Shaftesbury Show on Wednesday 14th August, 2019 with a Cream Tea in the BV Dairy Stand at the event will be awarded in each age group.

No cash alternative is available.

Image enhancing

BV Dairy is aware that digital photography does allow for some image enhancement. Minor burning, dodging, cropping and/or colour correction is acceptable and you must clearly note what changes have been made in the image description.

Use of images and copyright

By entering the competition, entrants and their subjects agree that any image submitted to the competition may be used by Millie's Photography Competition and its event partners for marketing and promotional purposes of the competition and the event only.

Millie's Photography Competition reserves the right to disqualify any entry that does not comply with the following requirements:

- You are the sole owner, photographer and copyright holder of the entry
- Entries submitted should contain no personally identifiable information about you, or any other person(s).
- Entries must not, at the sole and unfettered discretion of the organisers, contain objectionable or inappropriate content.
- Entries must not contain any material that could constitute or encourage conduct which would be considered a criminal offence, give rise to civil liability, or otherwise violate any law.
- Entries must not infringe upon the copyrights, trademarks, contract rights, or any other intellectual property rights of any third person or entity, or violate any person's rights of privacy or publicity, and your entry does not include:
 - *trademarks owned by third parties*
 - *copyrighted materials owned by third parties*

 - *entries which contain any commercial content that promotes any product or service*
 - *entries containing screen credits*

You confirm that any person depicted in the entry has granted permission to be portrayed as shown. Any costumes, props or other materials used must be rented or borrowed with the permission of the owner, and all other relevant permissions must have been obtained.

You also agree and acknowledge that Millie's Photography Competition is permitted to receive your registration data. All personal information will be used by Millie's Photography Competition in accordance with our strict data protection policy.

You must have your parent or legal guardian's consent to submit images to Millie's Photography Competition.

DV Dairy will only ever use personal data for the purpose of administering the scheme.

Entrants agree that personal data may be processed, shared, and otherwise used for the purposes and within the context of Millie's Photography Competition and Exhibition and any other purposes outlined in these Official Rules.

All entrants understand that any image submitted to the competition may be used in connection with the promotion of the event, including, but not limited to the following:
